OLD BUSINESS:

- SHOEMAKER STATED ONGOING REPLACEMENT OF METERS AND TRANSMITTERS HAVE BEEN TAKING PLACE. ONLY 20 REMAIN, 17 OF WHICH ARE PITS (INGROUND METER HOUSING). SHOEMAKER LATER EXPLAINED HAVING TWO TOWN EMPLOYEES COMPLETED WORK IS FOR SAFETY REASONS.
- SHOEMAKER EXPLAINED THAT HYDRANTS PAINTED A COUPLE OF YEARS AGO NEED REPAINTING.
 KENNEDY VALVE HAS BEEN CONTACTED FOR RECOMMENDATION OF LONG-LASTING PAINT.

COMMUNICATION FROM AUDIENCE:

MS. FRICK ASKED IF ALL METERS ARE BEING CHANGED OUT OR AS NEEDED. SHOEMAKER RESPONDED
METERS ARE CLOSE TO 15 YEARS OLD AND BATTERIES ARE DYING. ONCE ALL METERS ARE CHANGED,
TOWN IS ABLE TO MONITOR LEAKS. IN ADDITION, BADGER HAS AN APP FOR RESIDENTS TO MONITOR
THEIR NEW METER. THEY RECOMMENDED THAT ALL NEW METERS BE INSTALLED BEFORE APP ROLL
OUT.

NEW BUSINESS:

- SHOEMAKER REPORTED THAT A NEW SUBMERSIBLE PUMP IS ON ORDER FOR BACK UP.
- SHOEMAKER STATED HEALTH DEPARTMENT PROVIDED FINAL CHEMUNG COUNTY SANITARY SURVEY WITH FIVE CORRECTIVE ACTIONS, WHICH DEAN WETZEL HAS BEEN CONTRACTED TO COMPLETE.
- SHOEMAKER EXPLAINED GRANT APPLICATION IS FOR REPLACEMENT OF DIESEL FUEL GENERATOR WITH PROPANE GENERATOR AT PUMP HOUSE. CCDOH (CHEMUNG COUNTY DEPARTMENT OF HEALTH) WILL BE PROVIDING RECOMMONDATION FOR THE UPGRADE.
- SHOEMAKER INDICATED THAT SCADATEK TECHNICIAN SCHEDULED TO INVESTIGATE MALFUNCTION OF SENSOR AT WATER TANK RECENTLY REPLACED.
- SHOEMAKER MENTIONED TANK INSPECTION SHOULD BE SCHEDULED NEXT YEAR.
- SHOEMAKER TOLD THE BOARD THAT PROPERTY OWNER ON LANGFORD CREEK ROAD/CEMETERY ROAD
 WANTS TO CONSOLIDATE TWO PARCELS. ONE PARCEL IS SPLIT BETWEEN THE WATER DISTRICT AND THE
 TOWN. PROVIDING WATER TO PROPERTY WOULD BE OWNERS EXPENSE AND VERY COSTLY.
 CONSOLIDATING PROPERTY WOULD ALLEVIATE OWNER FROM ANNUAL FEE. SWAYZE INDICATED TOWN
 ATTORNEY SHOULD REVIEW TOWN'S OPTIONS.
