SHOEMAKER STATED 2022 WATER BUDGET HAS GONE DOWN BY \$5,000. VAN ETTEN WATER DISTRICT PAID OFF BOND IN AUGUST AND SAVED WATER DISTRICT \$42,560 IN INTEREST (FINAL PAYMENT WAS SCHEDULED FOR 2043). SHOEMAKER NOTED WOULD LIKE TO PAY OFF ONE MORE BOND IN 2022 AND SAVE ADDITIONAL \$55,000 (FINAL PAYMENT SCHEDULED FOR 2043) IN INTEREST. WATER DEBT SERVICE FEE WAS \$279.09 IN 2021 AND 2022 WILL BE \$268.13.
