TOWN BOARD OF VAN ETTEN WHEREAS, THE TOWN OF VAN ETTEN (THE "TOWN") IS THE OWNER OF A CERTAIN PARCEL OF REAL PROPERTY LOCATED IN THE TOWN OF VAN ETTEN, CHEMUNG COUNTY, NEW YORK, DESIGNATED AS TAX MAP PARCEL NUMBER 45.18-1-3.2, COMPRISING APPROXIMATELY 0.08 ACRE, AND COMMONLY KNOWN AS THE JAMES LAMPILA SKATE PARK (THE "PROPERTY"), SAID PROPERTY HAVING BEEN ACQUIRED BY THE TOWN IN CONNECTION WITH THE DISSOLUTION OF THE VILLAGE OF VAN ETTEN; AND WHEREAS, THE PROPERTY HISTORICALLY HAS BEEN USED BY VAN ETTEN YOUTH FOR SKATEBOARDING AND RELATED RECREATIONAL PURPOSES; AND WHEREAS, THE TOWN BOARD, HAVING REVIEWED THE UTILIZATION OF THE PROPERTY, HAS OBSERVED THAT THE PROPERTY INCREASINGLY IS USED FOR ACTIVITIES OTHER THAN SKATEBOARDING AND THAT SUCH ACTIVITIES TEND TO BE UNPRODUCTIVE AND POTENTIALLY DETRIMENTAL TO THE VAN ETTEN COMMUNITY; AND WHEREAS, SPENCER-VAN ETTEN CENTRAL SCHOOL DISTRICT (THE "SCHOOL DISTRICT") HAS EXPRESSED INTEREST IN ACQUIRING THE PROPERTY FROM THE TOWN SO THAT THE PROPERTY MAY BE INTEGRATED INTO ADJACENT LANDS OF THE SCHOOL DISTRICT AND USED FOR SCHOLASTIC PURPOSES OR THE EXPANSION OF THE SCHOOL DISTRICT'S TRANSPORTATION BUILDING; AND WHEREAS, THE TOWN BOARD, HAVING CONSIDERED THE PRESENT AND ALTERNATIVE USES OF THE PROPERTY, HAS DETERMINED THAT THE PROPERTY IS NOT REQUIRED FOR USE BY THE TOWN AND THAT CONVEYING THE PROPERTY TO THE SCHOOL DISTRICT IS IN THE TOWN'S BEST INTEREST, INSOFAR AS IT WILL ELIMINATE BOTH THE TOWN'S RESPONSIBILITY FOR MAINTENANCE OF THE PROPERTY AND THE POTENTIAL LIABILITY EXPOSURE ASSOCIATED WITH THE PROPERTY; AND WHEREAS, BASED UPON THE FOREGOING, THE TOWN BOARD WISHES TO AUTHORIZE THE CONVEYANCE OF THE PROPERTY TO THE SCHOOL DISTRICT, SUBJECT TO CERTAIN CONDITIONS; NOW, THEREFORE, BE IT RESOLVED, THAT THE TOWN BOARD, HAVING REVIEWED THE PROPOSED CONVEYANCE OF THE PROPERTY IN ACCORDANCE WITH ALL APPLICABLE REQUIREMENTS OF THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT ("SEQRA"), HEREBY DETERMINES THAT SAID CONVEYANCE IS AN UNLISTED ACTION UNDER SEQRA AND THAT SAID CONVEYANCE WILL NOT HAVE A NEGATIVE IMPACT ON THE ENVIRONMENT; AND BE IT FURTHER RESOLVED, THAT THE TOWN BOARD,

HAVING DETERMINED THAT THE PROPERTY IS EXCESS PROPERTY NOT REQUIRED FOR USE BY THE TOWN, HEREBY AUTHORIZES THE CONVEYANCE OF THE PROPERTY TO SPENCER-VAN ETTEN CENTRAL SCHOOL DISTRICT FOR NOMINAL CONSIDERATION, SUBJECT TO THE FOLLOWING CONDITIONS: (I) THE SCHOOL DISTRICT SHALL BE OBLIGATED TO PROVIDE FOR THE PAYMENT OF ALL FEES AND EXPENSES REASONABLY INCURRED IN CONNECTION WITH SAID CONVEYANCE, AND (II) THE SCHOOL DISTRICT, FOLLOWING ITS ACQUISITION OF THE PROPERTY, SHALL BE OBLIGATED TO ERECT A PLAQUE OR SIMILAR MARKER OR MONUMENT IDENTIFYING THE PROPERTY AS THE FORMER SITE OF THE JAMES LAMPILA SKATE PARK AND DESIGNATING SAID SITE AS THE JAMES E. LAMPILA AREA OF DISTINCTION, DEDICATED TO THE CONTINUED GROWTH OF YOUTH AND EDUCATION IN THE VAN ETTEN COMMUNITY, THEREBY PUBLICLY ACKNOWLEDGING MR. LAMPILA'S STANDING IN THE COMMUNITY AND HIS DEDICATION TO THE CITIZENS AND YOUTH OF VAN ETTEN AS A FORMER TOWN SUPERVISOR AND SCHOOL DISTRICT TRANSPORTATION DIRECTOR; AND BE IT FURTHER RESOLVED, THAT THE TOWN SUPERVISOR BE, AND HE HEREBY IS, AUTHORIZED AND DIRECTED TO EXECUTE SUCH DOCUMENTS, INCLUDING, WITHOUT LIMITATION, A QUITCLAIM DEED, AND TO TAKE SUCH OTHER ACTIONS AS MAY BE REQUIRED TO CARRY OUT THE CONVEYANCE OF THE PROPERTY AS CONTEMPLATED HEREIN; AND BE IT FURTHER RESOLVED, THE CONVEYANCE OF THE PROPERTY PURSUANT TO THIS RESOLUTION IS SUBJECT TO PERMISSIVE REFERENDUM AS PROVIDED IN SECTIONS 64(2), 90, AND 91 OF THE TOWN LAW OF THE STATE OF NEW YORK AND SHALL NOT TAKE EFFECT UNTIL THIRTY (30) DAYS AFTER THE DATE OF ITS ADOPTION, NOR UNTIL APPROVED BY THE AFFIRMATIVE VOTE OF A MAJORITY OF THE QUALIFIED ELECTORS OF THE TOWN THEREBY VOTING UPON SUCH PROPOSITION, IF WITHIN THIRTY (30) DAYS AFTER THE ADOPTION OF THIS RESOLUTION THERE IS FILED WITH THE TOWN CLERK OF THE TOWN A PETITION SUBSCRIBED AND ACKNOWLEDGED BY ELECTORS OF THE TOWN QUALIFIED TO VOTE UPON A PROPOSITION TO RAISE AND EXPEND MONEY, IN NUMBER EQUAL TO AT LEAST FIVE PER CENTUM OF THE TOTAL VOTE CAST FOR GOVERNOR IN SAID TOWN AT THE LAST GENERAL ELECTION HELD FOR THE ELECTION OF STATE OFFICERS.
